For new WAIT partners, there is a \$2500 certification fee when submitting the attached application. This fee includes the benefits of an "Owl" Corporate Membership as outlined on the next page.

For each subsequent year, WAIT Sites are required to apply for re-certification. The recertification process includes submission of a one-page narrative about the current status of the WAIT project at the site. There is a \$1000 recertification fee, per year. Recertification materials and fees are due by December 31st each year to be included in printed materials for the following calendar year. If your company is a corporate member of SCWF, then your WAIT recertification fees are waived, as detailed on the next page.

The \$1000 re-certification fee will include a business-card-size B&W ad in the Out of Doors newsletter in one issue, logo & listing on sponsor page of <u>www.scwf.org</u> website, and the opportunity for associates to join SCWF at \$20 per year (20% discount).

For industries with more than one site certified, under the same management company:

- \$5000 or \$10,000 corporate membership levels* will include re-certification of all sites
- \$2500 corporate membership level* will include re-certification of one site, other sites will need to pay the \$1000 per site.
